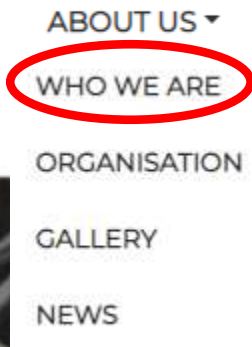

The Amber RFC is defined by Commission Implementing Decision (EU) 2017/177 with the following Principal Route: *Koper — Ljubljana —/Zalaszentiván — Sopron/Csorna —/(Hungarian-Serbian border) — Kelebia — Budapest —/Komárom — Leopoldov/Rajka — Bratislava — Žilina — Katowice/Kraków — Warszawa/Luków — Terespol — (Polish-Belarusian border).*

The name *Amber* RFC is special because it refers to the name of an important ancient trade route, which broadly followed the same alignment.

The Amber RFC is a beneficiary of the Connecting Europe Facility (CEF) - Programme Support Action (PSA) on the basis of the Multi-annual Work Programme 2014-2020, entitled "Establishment and development of the Amber rail freight corridor", action number 2016-PSA-RFC11.

Amber Rail Freight Corridor goes operational

With the publication of paths for international freight trains in mid-January 2019 the Amber Rail Freight Corridor reaches its operational phase. The main goal of the corridor is to facilitate competitive cross-border rail freight between important industrial centers and intermodal terminals of Poland, Slovakia, Hungary and Slovenia, including the Adriatic seaport of Koper, and to provide efficient links to Euro-Asian railway routes in Malaszewice at the border to Belarus and towards South-Eastern Europe via Kelebia, border station to Serbia.

About the C-OSS

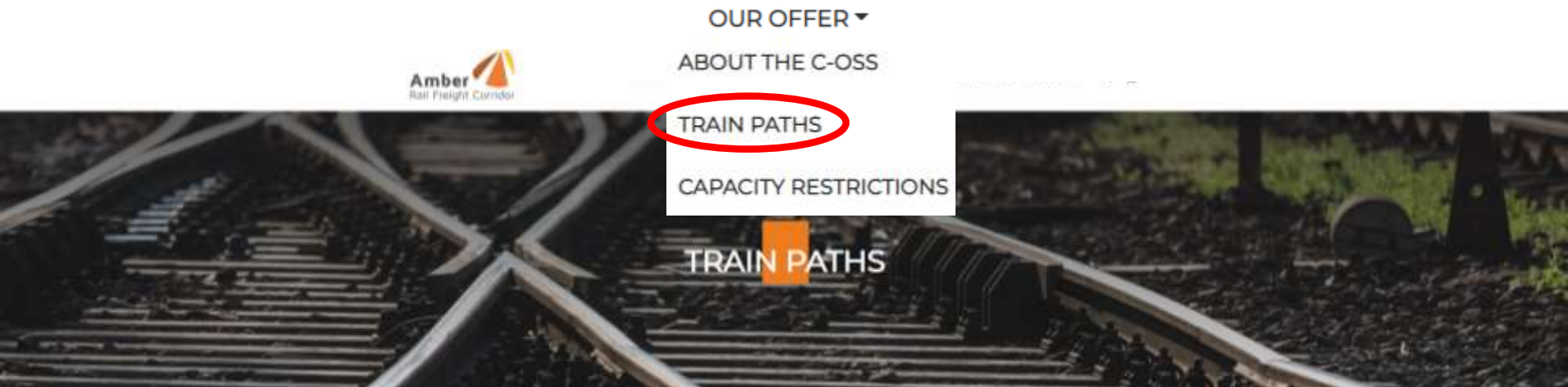

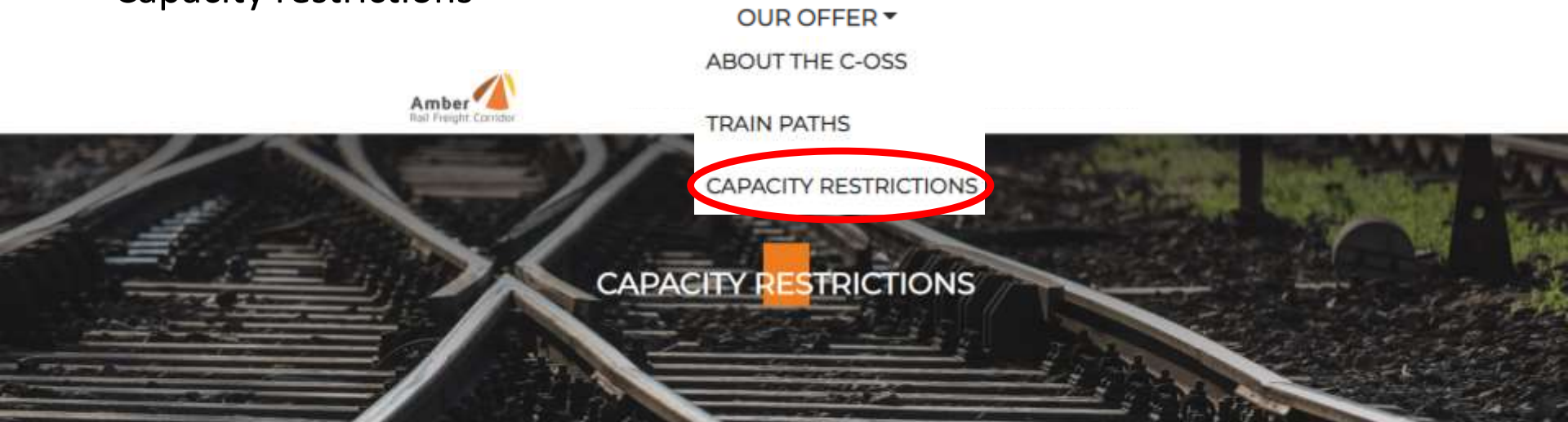

In accordance with the Regulation (EU) 913/2010 and RNE Guidelines for Coordination/Publication of Planned Temporary Capacity Restrictions RFC Amber publishes a single document which contains the overview of Temporary Capacity Restrictions on the Corridor.

The latest information on the Temporary Capacity Restriction of the RFC will be available soon. RFC Amber updates the coordinated TCRs at least twice a year. More information can be found in the CID Book 4.
