

PRIVACY AND COOKIES POLICY

On this page are described the management procedures of the website https://rfc-amber.eu/ concerning the processing of personal data of the users.

This information is supplied in compliance with section 13 of the Legislative Decree 196/03 (hereinafter Privacy Code) to the users of the services available on our website through the Internet.

This information is not valid for other websites that can be visited through the links available on our website, for which RFC Amber is not responsible in any manner.

Data Controller

The Data Controller of the users' personal data, concerning identifiable or non-identifiable persons, processed after the visit to our site, is RFC Amber, with registered office in H-1087 Budapest, Könyves Kálmán krt. 54-60. The Person in charge of responding to data subjects in case the rights as per Section 7 is Ms Eszter Boglárka Gádoros (Secretariat).

Data Processor

Data processing might be carried out solely by external parties which might be available via a direct link based on the particular topics. Thus, responsibility of data processing remains within the competency of the given external provider.

Place and purpose of data processing

The processing related to the services of this website is carried out exclusively through external sites. No data inherent to web services will be distributed. Personal data supplied by the users who ask for services are used only to supply the service or the required performance. Personal data are not communicated to third parties apart when law mandates the communication or this is strictly necessary for the fulfillment of the requirement.

Kind of processes

Data provided voluntarily by the users

The discretionary, explicit and voluntary transmission of electronic mail to the addresses indicated on this site implies the acquisition of the senders' address, necessary for answering the request, as well as some other personal data included in the message.



Cookies

Cookies are small data files stored on the user's PC hard disk. Cookies have the function to accelerate web traffic analysis or to indicate when a specific web site is visited and allow web applications to send information to the single user. On this website RFC Amber uses only technical cookies; these cookies are functional to navigation and ensure the safety and the efficiency of the website.

The information systems and the software procedures used for the management of the website acquire during the normal exercise some personal data that must be necessarily transmitted for the use of Internet communication protocols. This information is not collected to be associated to identified subjects, but for its very nature, this information could allow, through elaborations and associations with third parties data, to identify the users. This category of data concerns IP addresses or computer domain names used by the users to connect to the website, URI (Uniform Resource Identifier) of the requested services, the time information of the request, the method for submitting the request to the server, the dimension of the file delivered as an answer, the status identification number of the answer of the server (ok, error....) and other parameters related to the operating system and the computer system of the user. These data are used for the sole purpose of obtaining anonymous statistical information concerning the use of the website and to check its correct functioning; these data are deleted immediately after processing. These data could be used to check the responsibility in the case of hypothetical computer crimes to the detriment of the website and can be communicated to the judicial authority, in case the latter explicitly requests such data.

Faculty for the supply of data

Besides, as already specified for web surfing data, the user is free to supply personal data to receive the services offered by RFC Amber. The missing data can imply the impossibility to obtain the requested service.

Rules of procedure of data processing

The personal data are processed through manual and automatic means, for the time necessary to the fulfillment of the purpose they have been collected for. Specific security measures are observed to prevent data loss, illicit or incorrect use, and not authorized access.

Rights of the data subjects

We inform you that you can exercise the rights described in section 7 of the Legislative Decree 196/03, including the right to obtain from the Data Controller the confirmation of the existence of your personal data and to demand, in case, the communication of those data. You have the right to know the source of the data, as well as the logic and purpose of the processing. You have the right to obtain the cancellation, the transformation into anonymous form or the block of the data processed in breach of the law, as well as the update, correction or, where there is the interest, the integration of the same data; or the right to oppose, for legitimate reasons, the processing writing to Ms Eszter Boglárka Gádoros (Secretariat, secretariat@rfc-amber.eu) of the RFC Amber, which is the person in charge of responding to data subjects.
